Governing Body

The institution has a strong governing council made up of different luminaries from various walks of life that devices all policies and decisions related to both academic and administration. To ensure the efficiency and effectiveness of governing council, a number of academic and administrative bodies have been formed with duties and responsibilities. The college's governing council meets once a year to address various topics and factors that affect the college's growth. The planning and monitoring board's ideas are addressed during the meeting. Major Responsibilities of Governing Body

2. To review the academic activities of the college To review the administrative activities of the college
3. To suggest the Principal and Management with various ideas to enhance the quality of academic and administrative system.
4. To review the Placement Training Activities and Career Assurance
5. Reviews the performance of the Institute and guide to function effectively to Achieve Excellence in Academics, Research and Industry collaborations.
6. To consider introduction of new courses and changes intake for the next academic year.
7. Reviews to apply Accreditations of different regulatory bodies (NBA, NAAC, Autonomous etc.)
8. Encourages and gives directions to apply for funds from different funding agencies.
9. Approve the budget for the respective financial year.

Functions of Governing Body

1. Amend and approve policies from time to time.
2. Approve the appointment of faculty members recommended by the selection committee of the institution in accordance with the norms prescribed by AICTE and Anna University.
3. Suggest strategies for the construction and maintenance of infrastructure and amenities for the institution.
4. Review of academic performance of the institution and suggest remedial measures, if required.
5. Review of mobilizes funds and utilize the resources maximum, towards the development of the institution.
6. Introduction of new programs and/or increasing intake/closure of programs/reduction in intake.
7. Implement the recommendations of the planning and monitoring board.
8. Review of highlighted feedback summary of stakeholders and planning for corrective actions towards the satisfaction of stakeholders.
